



## Girl Scouts of Northern New Jersey

### Certificates of Liability Insurance on File For Troops/Service Units using outside facilities

Please check to see if a **Certificate of Insurance** is listed below.

- If not, please contact the facility to request a Certificate of Insurance naming Girl Scouts of Northern New Jersey, 95 Newark Pompton Turnpike, Riverdale, NJ 07457 as Certificate Holder. In addition, it is 'best practice' to have Girl Scouts of Northern New Jersey listed as additionally insured. Insurance coverage of \$1,000,000 is required.
- Buses used for transporting Girl Scouts must provide \$ 5,000,000 coverage. For transporting short Girl Scout trips within the state, buses must provide \$ 5,000,000 coverage. School buses cannot travel interstate unless they are certified as a D.O.T. bus (Federal Regulation # 1043.2). Contact your Troop Support Manager for Bus Contract/Insurance Coverage Form.

- A COI is not needed if the facility being used is a municipal, state, county, or federal government agency.
- Non-member Girl Scout Groups that use GSNNJ facilities must send a current and original copy of the group's Certificate of Liability Insurance (coverage of at least \$1,000,000), naming GSNNJ as additionally insured.
