

Girl Code of Conduct

Girl Scouts of Northern New Jersey

As a **Girl Scout** and member of **Troop #** _____

I agree that the following statements are true, and that they will be in effect every time I participate in a Girl Scout meeting or activity.

I understand that my attitude and the way I behave are important to my success and the success of others in my troop.

I agree to behave according to the Promise and Law and to:

1. Be respectful:

I will behave in a respectful manner with my leaders and my sister Girl Scouts. I will listen, not interrupt and will ask questions calmly. If I am angry, I will express my opinion in a respectful and kind way. No gossip at any time.

2. Be responsible:

I will follow the instructions and rules my leaders made to protect us and will do my best to help that our meetings and activities are safe and fun. No texting or making phone calls during meetings and events.

3. Be compassionate:

I will not insult, bully, or abuse others in any way, including hitting, slapping, spitting, calling hurtful names, or engaging in any unwanted or inappropriate touching. I understand that if someone tells me they are uncomfortable, I will stop immediately. I understand that violence or inappropriate physical contact of any kind will not be tolerated. My parents/guardians, as well as the parents/guardians of anyone involved, will be notified immediately. I will avoid hurtful conversations and actions at all times.

4. Be honest:

I will treat other people, myself, property and equipment with integrity, care and consideration. I will not take home what does not belong to me.

5. Be a sister to other Girl Scouts:

I will treat others as I would like to be treated at all times. I will be considerate of the feelings of others.

6. Use resources wisely:

I will not waste supplies. I will only use what is needed. I understand that money earned from any Girl Scout Product Program or activity becomes the property of the entire troop, not my own.

Additional troop agreements:

If by my words and my actions I do not follow these statements:

1st offense: I agree that I will not be able to attend the next troop meeting or event, and written documentation will be sent home.

2nd offense: I will not be able to attend any troop meeting or events for 1 month and written documentation will be sent home.

3rd offense: My parent/guardian will be required to attend all troop meetings/events with me.

4th offense: I will be asked to leave the troop and seek other participation option to continue in Girl Scouts.

By signing this document, I commit to adhering to the above Code of Conduct. Failure to do so does not affect the applicability of the code or any of its provisions to you.
